Paul Volodarsky, Esq. appeared on behalf of Respondent, Danella Const. of NY, and moved for dismissal on the grounds of improper service. He presented a letter from Respondent, stating that the person served was not authorized to accept service. He also stated that he had spoken with the person served, who told him that she knew she was not authorized to accept service, but as a receptionist, she accepts what people hand her.

Gale Travis appeared for Petitioner and presented photos taken by the issuing officer. She also stated that it is standard practice for the process server to go to the office with a list of authorized persons, to ask a person is he/she is authorized and to get a signature on a form. However, she was unable to present the form and did not wish to have an adjournment to obtain additional evidence.

I find Respondent's evidence credible and dismiss these Notices of Violation for improper service.
